Mayor Powell opened the meeting with the Pledge of Allegiance.

Motion by Trustee Stolz the minutes of September 25th, 1990 be approved.

Mayor Powell seconded the motion. Motion carried.

Attorney Lubow presented a completed copy of the "Unregistered Motor Vehicle Law" which was mailed to the Sec. of State after correcting Section 5C.

Attorney Lubow received a letter from Mrs. McSweeney claiming that her clothes were ruined at the Laundromat [Wm. Beck] when there was a break in the water line.

Motion by Mayor Powell that Attorney Lubow send a letter in response, stating that the village is not responsible for any damages in accordance to our rules and regulations ordinance-Section 6 "Shutting Off Water". A copy of letter to be sent to Mr. Wm. Breck.

Motion by Mayor Powell that the Village purchase uniforms for the men on the highway and also water department and same to be cleaned each week. Cost to be charged to water, streets and garbage.

Trustee Stolz seconded the motion.. Motion carried.

Mayor Powell offered a motion that this years CHIPS program be the South Main Street project.

Warner Byrnes sent a letter stating that his septic system is failing and asked that since the City of New York was doing repair work, would the City consider hooking him up to the sewer system? Letter was sent by Mr. Byrnes to Mr. J. Boek, City of New York engineer.

A letter was received from Mrs. Mary Sadyan [Penrose Park] complaining of water that "ends up by the street in front of her home and stays there".

Mayor Powell said he would have Fritz Carlson check this out and will answer Miss Sadyan.

Attorney Lubow offered a suggestion that the Village of Tannersville take over the parking area at the Video store. Same to be further discised.

Attorney Lubow also brought up the water situation on Penrose Park stating he had spoken with Mrs. Rem, he suggested that village men go in with a back-hoe and do the necessary work.

Mayor Powell stated he will talk with the board members regarding same.

Treasurer presented receipts and disbursements commencing June 1, 1990 to September 30, 1990 for audit and approval.

Motion by Mayor Powell that analysis be approved.

Trustee Stolz seconded the motion. Motion carried.




