Mayor Powell seconded the motion. Motion carried.


Motion by Trustee Stolz that we accept the Greene County Bituminous Materials Bids.

Trustee Reich seconded the motion. Motion carried.


Motion by Trustee Reich that Bruce Feml be Dog Warden.


