

AGREEMENT TO SHARE SAND AND SALT FACILITY

At a regular meeting of the Village Board of the Village of Tannersville duly held at the Village Hall in such Village on the 1st day of Feb, 1999. Upon the calling of the roll by the Clerk the following members were:

The following resolution was offered for adoption by William Reich, which resolution was seconded by Mark Rubinger.

Resolution Authorizing the Mayor of the Village of Tannersville to sign an agreement on behalf of the Village which authorizes the Mayor to directly contract with the Town of Hunter to share use of a sand and salt storage facility.

WHEREAS, the Village of Tannersville has the power and authority to contract for the purpose of renting, leasing, or sharing use of facilities and property with other municipalities, and

WHEREAS, it is hereby determined that by sharing a sand and salt storage facility with the Town of Hunter, the Village will avoid the necessity of constructing and maintaining a separate sand and salt facility, thereby saving the taxpayers money, and

WHEREAS, it is hereby determined that it will be in the best interests of the Village to be a party to such an agreement,

NOW THEREFORE, BE IT RESOLVED, that the Mayor of the Village of Tannersville is hereby authorized to sign on behalf of the Village, the following agreement:

AGREEMENT TO SHARE USE OF SAND AND SALT FACILITY

The undersigned municipalities have caused this agreement to be executed and to bind said municipalities to the terms of said agreement.

WHEREAS, the Town of Hunter and the Village of Tannersville desire to enter into an intermunicipal agreement for the purpose of sharing space at a sand and salt storage

facility to be constructed on Town of Hunter property using funding from the Catskill Watershed Corporation,

NOW THEREFORE, BE IT RESOLVED, that the Town of Hunter and Village of Tannersville agree as follows:


1. The Town of Hunter will construct a sand and salt storage facility using funding from the Catskill Watershed Corporation.
2. The Town will provide access to the Village to its sand and salt storage facility for use by the Village to store and access sand and salt materials.
3. The Village will provide its own materials which may be mixed and commingled with like materials kept by the Town of Hunter at said facility.
4. The Village will compensate the Town of Hunter for any materials purchased by the Town of Hunter and used by the Village of Tannersville.
5. This contract shall continue in perpetuity and may be terminated only by written agreement of the parties to this contract.

IN WITNESS WHEREOF, the said Village of Tannersville has by order of the Village Board, caused these presents to be subscribed by the Chief Executive Officer, and the seal of the Village to be affixed and attested by the clerk thereof, this 22nd day of Feb, 1999.
